The purpose of this letter is to provide a required report in accordance with 10 CFR 50.46, "Acceptance criteria for emergency core cooling systems for light-water nuclear power reactors," for the Vogtle Electric Generating Plant (VEGP) Units 3 and 4 combined licenses (COLs), License Nos. NPF-91 and NPF-92, respectively.

On March 18, 2022, Westinghouse Electric Company, LLC (WEC) submitted to the NRC their annual report required by 10 CFR 50.46 (Westinghouse letter DCP_NRC_003346, 10 CFR 50.46 Annual Report for the AP1000® Plant Design) [ADAMS Accession Number ML22083A145].

As documented in Attachment 2 of WEC's annual report, there are no changes or errors to report for VEGP Units 3 and 4 for 2021.
