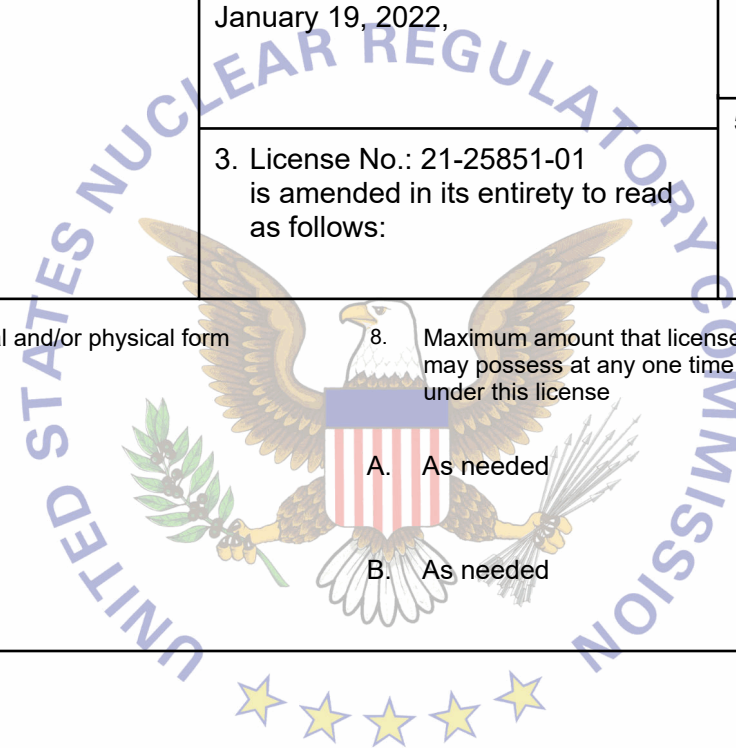


MATERIALS LICENSE

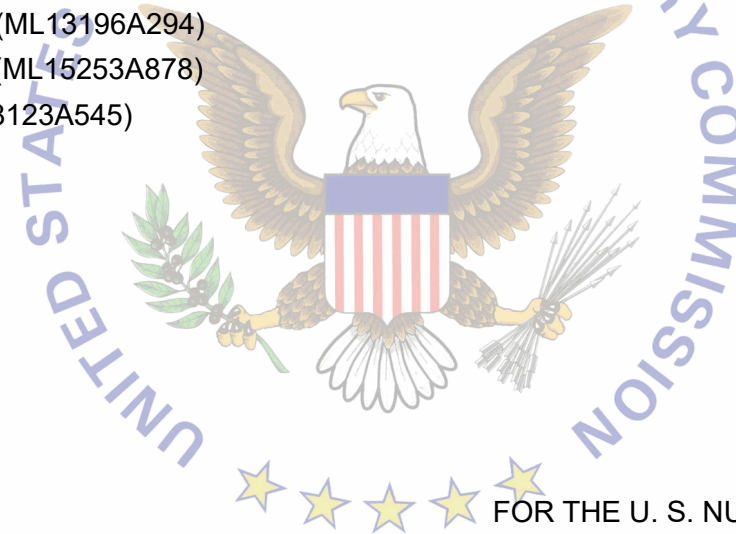
