I talked with the NRC technical reviewer assigned to the NOG-L decommissioning funding plan submittal dated December 7, 2021 (ADAMS Accession Number ML21344A061). The NRC reviewer expects that the only request for additional information is in regards to the \$46,178,218 figure in the decommissioning cost estimate for the LTC that does not appear to align with the associated surety bond. As we discussed on the phone, NOG-L should submit any page changes needed to correct the dollar figure(s) in the submittal. The additional information should be provided within 30 days from the date of this email.

Pending your response, we anticipate completing our review by June 23, 2022. This date could change depending on the findings of our technical review, urgent assignments, or other factors. We will promptly communicate any significant changes to this schedule.
