SUBJECT: SUMMARY OF APRIL 6, 2022, PUBLIC MEETING WITH ARIZONA PUBLIC SERVICE COMPANY TO DISCUSS UPCOMING LICENSE AMENDMENT REQUEST TO ADOPT TECHNICAL SPECIFICATIONS TASK FORCE TRAVELER TSTF-487 FOR PALO VERDE NUCLEAR GENERATING STATION, UNITS 1, 2, AND 3 (EPID L-2022-LRM-0025)

On April 6, 2022, an Observation public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and Arizona Public Service Company (the licensee) via teleconference. The purpose of this meeting was to discuss the licensee's upcoming license amendment request to revise the technical specifications (TSs) by adopting Technical Specifications Task Force (TSTF) Traveler TSTF-487, "Relocate DNB [Departure from Nucleate Boiling] Parameters to the COLR [Core Operating Limits Report]," at Palo Verde Nuclear Generating Station, Units 1, 2, and 3. The meeting notice and agenda, dated March 22, 2022, are available in the NRC's Agencywide Documents Access and Management System (ADAMS) at Accession No. ML22081A256. A list of attendees is provided in the enclosure.

The licensee provided slides for this public meeting, which are available in ADAMS at Accession No. ML22096A005. The licensee's presentation included the proposed revisions to the TSs. In addition, the licensee stated that it is planning to submit this application by the middle of April 2022 and will request NRC approval by 9 months.

No members of the public called into the meeting. No regulatory decisions or commitments were made at the meeting. No Public Meeting Feedback forms were received.
