Enclosed is Amendment No. 01 to BAMF Health, LLC's (your) U.S. Nuclear Regulatory Commission (NRC) Materials License No. 21-35632-02 in accordance with your March 16, 2022 letter requesting to (1) change mailing and location of use addresses from Monroe Ave. NW to Michigan St. NW; (2) add one Title 10 of the *Code of Federal Regulations* (10 CFR) Section 35.300 authorized user Brandon R. Mancini, M.D.; and (3) increase the 10 CFR 35.300 overall possession limit. You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.
