Dear NRC Representatives:

This letter is in response to your inquiry regarding the American Board of Medical Physics, and your review of the ABMP with respect to its Continued Recognition as an NRC Specialty Board. The following items are confirmed:

- 1. Confirm the specialty board's current name: American Board of Medical Physics
- 2. Confirm the name of the Specialty Certification(s) or Certificates: Medical Health Physics
- 3. Confirm that the specialty board still satisfies the board recognition criteria in 10 CFR 35.50, "Training for Radiation Safety Officer and Associate Radiation Safety Officer": The ABMP continues to satisfy the board recognition criteria set forth in 10 CFR 35.50.
- 4. Confirm that there have been no changes in the board's certification procedures that could affect the recognition status: The ABMP confirms that there have been no changes that could affect its recognition status.
- 5. Confirm that the enclosed certificate (attached as "ABMP Plaque OLD SAMPLE") is current: There has been a modification that allows the Seal of the ABMP to be placed on the plaque, and the RSO-Eligible designation is now under the Specialty Designation, in the center (attached as "ABMP Plaque SAMPLE1").

Concerning Question #2, it is noted that the ABMP also offers specialty certification in MRI Physics, which is not an NRC-recognized specialty certification, nor does the ABMP wish for it to be. This is noted only for completeness.
