Dear Ms. Wallace:

Enclosed is a corrected copy to Amendment No. 5 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 21-32557-01 in accordance with your requests dated January 12, 2022, March 1, 2022 and April 12, 2022.

Following a review, Condition 10, has been corrected to list the authorized storage location of your portable gauging device.

Your license was amended to reflect the removal of your former permanent storage sites located at:

- 15307 M-60, Three Rivers, Michigan; and
- 8134 W. Main St., Kalamazoo, Michigan.

Your request identified that all radioactive materials have been removed from these former permanent storage locations. Further, your request provided a leak test report for the portable gauging device previously stored at these locations. I have reviewed this information and have concluded that all licensed radioactive material has been removed from the former locations and there is no evidence of residual radioactive contamination attributable to licensed activities. Therefore, the former facility is suitable for release to unrestricted use.

Your license has been amended to restrict possession of radioactive materials for storage only pending disposal. Please inform the agency following the completion of the transfer/disposal of licensed radioactive material or any changes in personnel or your radiation protection program.

You have been designated as the individual responsible for supervising the safe storage of the portable gauging device that remains in your possession. Your request did not include documentation of your radiation safety training and experience. Within 30 days of the date of this license amendment, please submit documentation of the completion of applicable radiation safety training and experience.

If there are any errors or questions, please notify the U.S. NRC Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (CFR) Section 51.22(c).

You will be periodically inspected by NRC.
