
1. Confirm the specialty board's current name:

 - i. 10 CFR 35.190, "Training for uptake, diution, and exrection studies."
 - ii. 10 CFR 35.290, "Training for imaging and localization studies."
 - iii. 10 CFR 35.390, "Training for use of unsealed byproduct material for which a written directive is required."
 1. The Nuclear Medicine Program Director must verify that the physician has successfully completed the training and experience requirements of the Nuclear Regulatory Commission as described in parts 10 CFR 35.190, 10 CFR 35.290 and 10 CFR 35.390, and complete an "[Evaluation of Clinical Competence Form](#)." A physician will not be eligible for ABNM certification without a Program Director's verification of training and clinical competence.

4. Confirm that there have been no changes in the board's certification procedures that could affect the recognition status.
