On April 5, 2022, the Nuclear Regulatory Commission (NRC) conducted an online virtual meeting concerning Joseph M. Farley Nuclear Plant Units 1 and 2, and Edwin I. Hatch Nuclear Plant Units 1 and 2. The purpose of the meeting was to provide opportunities for the public to discuss the annual assessment for the period of January 1, 2020 - December 31, 2021.

In response to the COVID-19 coronavirus and updated Federal Government guidance on travel and social distancing, the meeting was held remotely through the Microsoft Teams application.
