Hello Everyone,

Below is a summary of our call today – let me know if I missed anything. Have a lovely weekend!

1) Programmatic Agreement status – Christine provided an update, noting that she sent the latest version of the PA out on Tuesday and that she will be following up with the NNTHPO and the BIA contacts individually since we have not yet heard from them.

2) EIS status, NNEPA and other agency reviews (review period is planned for a 2-week period from 2/28 through 3/14) – Christine provided an update on the EIS and described the structure of Appendix B (comment summaries and responses). We agreed to have a call to walk through the comment-response appendix, etc. on the afternoon of 2/28. Christine sent an appointment for this call. Christine reiterated that the review period will be 2 weeks; if the NRC is late in sending the documents out for review for any reason, the review period will likewise be pushed out the same number of days (will remain a 2-week period).
