This refers to your license amendment request dated January 25, 2022. Please find enclosed Amendment No. 34, adding Dr. Chad Mitchell as radiation safety officer, Dr. Padha for 35.100 and 35.200 uses, and removing Dr. Misailidis as radiation safety officer and an authorized user as you requested.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
