Dear Mr. Bowers:

This refers to your letter dated January 26, 2022, requesting that Christiana Care Health System be granted a temporary exemption from regulatory requirements for your U.S. Nuclear Regulatory Commission (NRC) License No. 07-12153-02 due to the COVID-19 Public Health Emergency (PHE). Specifically, you requested an exemption from Annual Radiation Safety Training requirements described in 10 CFR 35.310(a), 35.410(a), and 30.34 for year 2022. Your exemption request is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML22032A048.

Based on your letter dated March 22, 2022, you informed us that you no longer need the requested action and you are withdrawing the exemption request. Therefore, we have administratively closed your license exemption request. Note that if you submit a new request at a later date, you may refer to Control No. 629941 for the documentation you have already submitted.
