Dear Dr. Crawley:

This refers to the license amendment request dated March 9, 2022 for Diagnostic Imaging Centers, P.A., NRC License No. 15-32819-01. We reviewed the request in accordance with the NRC licensing guidance in NUREG-1556, Volume 9, Revision 3 and will need the following.

1. The board certification (The American Board of Radiology with specialty area in Diagnostic Radiology) for Dr. Numukunda Darboe, Jr. is not recognized by the NRC for the Radiation Safety Officer (RSO). For your information, the recognized boards are listed on the NRC's website at <https://www.nrc.gov/materials/miau/med-use-toolkit/spec-board-cert.html#3550>. Therefore, he does not meet the requirement in Title 10 of the *Code of Federal Regulations* (10 CFR) 35.50(a). However, he may meet the requirement to be the RSO specified in 10 CFR 35.50(c)(2). If you would like to pursue this path, please correct Part 1 of Form 313 (RSO) for Dr. Darboe, Jr. and complete Section 5.c. of the form.
2. Provide a copy of the delegation of authority for the new RSO (a sample is attached for your reference).
3. Based on Section 4.7.2.3 of NUREG-1556, Volume 20, Revision 1, please provide contact information (i.e., work phone number, email address, and facsimile number) for the new RSO.

To continue the review of your application, we request that you submit your response under a dated and signed cover letter by April 28, 2022. In the cover letter, please refer the license number, docket number and Mail Control No. 630399.
