Clearon Corporation facility license 47-24837-01, is please to inform you that management on the certifying official and Radiation Safety Officer (RSO) has changed on the materials license for fixed gauges. The new appointed certifying official will now be Clarence Evenson instead of John McKitrick as John has left the company. Mr. Evenson is the Chief Operating Officer and is a part of many regulatory agency certifications, which he understands the importance of being diligent with radiation safety. We request that the license be amended to Clarence Evenson as the Certifying Official.

For the RSO, Clearon has indicated two RSOs for our program. The first appointee for RSO is Katie Musick. She has attended training at Radiation Solutions Inc. for fixed gauges. Her RSO training was completed as of Monday, April 18, 2022 and a copy of the corresponding certification is enclosed. The second appointee for RSO is Tonya Presley. She has attended the same training as Ms. Musick. Her RSO training was completed as of Wednesday, April 20, 2022, and a copy of the corresponding certification is enclosed as well.

Going forward, Ms. Musick and Ms. Presley will assume all duties and responsibilities of an RSO, including ensuring radiological safety and compliance with both NRC regulations and the conditions of the above-mentioned license. We request that the license be amended to list Katie Musick and Tonya Presley as the Radiation Safety Officer.

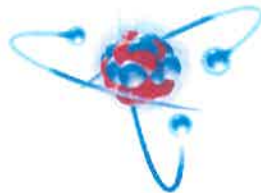
