The acute care hospital, doing business in Grand Rapids, Michigan, formerly doing business as Mercy Health Saint Mary's and now doing business as Trinity Health Grand Rapids Hospital, is an operating division of Trinity Health-Michigan, a Michigan nonprofit corporation. Trinity Health-Michigan has undertaken re-branding activities throughout the state of Michigan, which includes re-branding this hospital, formerly doing business as Mercy Health Saint Mary's. This is being done to better align the name of each hospital with the brand of the non-profit Parent Corporation (Trinity Health Corporation). The re-branding activity merely changes the assumed name under which the hospital is doing business. There has been no change in ownership, no change in the Board of Directors and no change in the physical addresses.

There was no change of control as described in NUREG 1556, Volume 15, Revision 1.
