TRAINING: No special training is required for any documents issued with this Change Notice.

REMARKS: IMC 1245, "Qualification Program for Reactor Inspectors." This revision corrected editorial items such as the names of offices that had changed and recognized the development of a new qualification program for research and test reactor examiners.

Since the NRC incident response program underwent a significant change in 2021, an additional training requirement was added for previously qualified inspectors to complete ISA-6, which provides an overview of the NRC incident response program, prior to reinstating their qualifications.

This change allows the use of an alternate inspector training and qualification program as long as the alternate program met the KSAs that the original training program was based upon.

Finally, additional guidance was provided regarding the process for accepting previous work experience as credit for the NRC inspector training program.

IP 93800, "Augmented Inspection Team." Revised to include guidance that is being relocated from the handbook for MD 8.3. Specifically, qualifications, scheduling, coordination with Office of Public Affairs, evidence preservation, and equipment quarantine.

IP 93812, "Special Inspection." Revised to include guidance that is being relocated from the handbook for MD 8.3. Specifically, qualifications, scheduling, coordination with Office of Public Affairs, evidence preservation, and equipment quarantine.

IMC 0611 Attachment 2, "Guidance for Reactive Inspection Reports." Added directions for report distribution.

IP 95003, "Supplemental Inspection Response to Action Matrix Column 4 (Multiple/Repetitive Degraded Cornerstone) Inputs." Relocated General Requirements and Guidance common to Supplemental Inspections to IMC 2515 Appendix B "Supplemental Inspection Program" to reduce unnecessary replication. Addresses and closes ROP FBFs 95003 2288 and 95003-2317. IMC 0040 format exception approved by IRIB branch chief.
