Dear Don Shaw:

By letter dated December 16, 2021 (Agencywide Documents Access and Management System Package Accession No. ML21350A282), TN Americas LLC submitted an amendment request for Revision No. 4 to Certificate of Compliance No. 9313 for the Model No. TN-40 package. The staff performed an acceptance review of your application to determine if it contained sufficient technical information in scope and depth to allow the staff to complete a detailed technical review.

Observations from our acceptance review are included in the enclosure to this letter. However, the application contains the necessary information to begin our detailed technical review. We have established a schedule for the review of your application which allows for the staff to issue a possible request for additional information by the end of December 2022, and a certificate of compliance and safety evaluation report by early December 2023, based on you responding to our request for additional information by May 31, 2023. The staff estimates that completing the safety review of this application will require approximately 500 staff hours.
