Dear Mr. Tasset:

This correspondence refers to your license amendment request dated April 21, 2022. Please find enclosed Amendment No. 7 to your U.S. Nuclear Regulatory Commission (NRC) License No. 15-29260-01 in accordance with your request.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. An environmental assessment for this action was not required since this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (CFR) 51.22(c).

In your letters dated April 21, 2022 and May 25, 2022, you described the material used and provided the leak test results for a location of use located 550 E. Saint Louis St., Springfield, Missouri. Further, you confirmed that all residual licensed material used at this location had been removed – such that any remaining residual radioactivity is within the limits of 10 CFR Part 20, Subpart E.

Based on review of the information provided, the staff has concluded that all licensable radioactive material has been removed from the location of use and residual radioactive material attributable to licensed activities in this location of use does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required. Your facility at 550 E. Saint Louis St., Springfield, Missouri is suitable for unrestricted use.

You will be periodically inspected by the NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action(s) against you. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking your license as specified in the NRC Enforcement Policy.
