By letter dated September 1, 2021 (Agencywide Documents Access and Management System [ADAMS] Accession No. ML21244A485), Orano Federal Services LLC submitted an application for approval of the Crystal River 3 Middle Package (CR3MP). On February 14, 2022, staff accepted your application for review after receiving on January 6, 2022 (ADAMS No. ML22006A365), your responses to our October 14, 2021, request for supplemental information (ADAMS No. ML21286A798).

The information needed to continue our review is described as a request for additional information (RAI) in the enclosure to this letter.
