Subject: Remediation of Identified Licensed Materials

Discussion: A video teleconference was held between members of NRC Region I and Alecto's Executive Vice President to discuss the materials identified at the Ohio Valley Medical Center location and the licensee's proposed actions. The NRC informed the licensee that a licensed waste broker confirmed the presence of radioactive materials while onsite on May 26, 2022. In response, the licensee's representative, Mr. Sarrao, confirmed that he would reach out to the Assistant City Manager for the City of Wheeling to discuss the waste broker's report and the next steps to take for the removal of the material. The NRC committed to providing Mr. Sarrao with the necessary contact information. The licensee committed to providing feedback to the NRC by June 10, 2022, on the outcome of these discussions and proposed actions.

Action Required:

- 1) Provide public contact information for the Assistant City Manager for the City of Wheeling to Alecto's Executive Vice-President
- 2) Establish a follow-up meeting with Alecto's Executive Vice-President to discuss the outcome of the licensee's and city's discussions and proposed actions to address the identified waste.
