Dear Mr. Jackson:

Enclosed is Amendment No. 75 to your NRC Materials License No. 21-11850-01 in accordance with your request dated March 31, 2022.

Please note that all of your requests in the aforementioned letter were granted. Of particular note, you now have increased flexibility to change procedures related to Y-90 microsphere use. Also, please note that you have authorization for a new Varian BRAVOS HDR unit. However, please note that Condition 10.B. of the license limits you to possessing only two sources at any one time between the current VariSource HDR unit and the new BRAVOS unit.

Please review the enclosed documents carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
