Reply to a Notice of Violation; EA-22-043. Reference: Letter EA-22-043 NRC Inspection report 030-38881/2022-001; Exercise of enforcement discretion; and notice of violation.

Dear Sir or Madam:

As required by 10 CFR, this letter provides Hayre McElroy & Associates reply to Notice of Violation EA-22-043. The response, as describes in the enclosure, includes the reason for the violation, the corrective steps that have been taken and the results achieved, the corrective steps that will be taken and the date when full compliance was achieved.

### **Reason for Violation**

The root cause of the violation was determined to be that Hayre McElroy & Associates failed to confine its possession and use of byproduct material to the purposes authorized in the license, specifically conditions 6.A through F.-9.A within the NRC license 46-35280-01.

# **Corrective Steps and Results Achieved**

Upon notification of the non-conforming condition, immediate action was taken to provide the purchase source, the letter of transfers and the required documents to add the Instrotek, Inc 3500 Xplorer nuclear gauge to license 46-35280-01. Compiled letter of transfers, leaks tests and calibrations for the Instrotek, Inc Model 3500 Xplorer and provided to NRC representative Dr. Janine F. Katanic. Submitted the letter of amendment to our NRC License No. 46-35280-01 for the addition of the Instrotek, Inc Model 3500 Xplorer nuclear gauge on 5/5/2022 to NRC Representative Carol Hill. Since the event which let to the notice of violation the Instrotek, Inc 3500 Xplorer nuclear gauge has been not in use and properly stored and secured until the approval of the amendment.

### **Date When Full Compliance Will be Achieved**

Full compliance with 10 CFR 30.34(c) is currently pending and will be processed within 90 days from 5/5/2022.
