Dear Mr. Dixon:

We have reviewed the license amendment request dated April 26, 2022, for Acuren Inspection, Inc., NRC License No. 22-27593-01. Based on the review, we will need the following.

The NRC regulations in Tittle 10 of the *Code of Federal Regulations* (10 CFR) 34.42, "Radiation Safety Officer for industrial radiography", requires the radiography licensee to have a qualified Radiation Safety Officer (RSO). The licensee will appoint and delegate the duties and responsibilities to manage its radiation safety program to the RSO in writing. NUREG–1556, Volume 2, Revision 1, Appendix O, "Model Delegation of Authority,"

provides an example of how to document a person accepting the responsibility of becoming an RSO (see attached sample).

Please provides a copy of the memo of the delegation of authority for the RSO signed by the licensee and the proposed RSO.

To continue the review of your application, we request that you submit your response under a dated and signed cover letter within 30 days. In the cover letter, please refer the license number, docket number and Mail Control No. 630846. Chris Dixon, you have been appointed radiation safety officer and are responsible for ensuring the safe and secure use of radiation. You are responsible for managing the Radiation Protection Program, identifying radiation protection problems, initiating, recommending, or providing corrective actions, verifying implementation of corrective actions, stopping unsafe activities, and ensuring compliance with regulations. You are hereby delegated the authority necessary to meet those responsibilities, including prohibiting the use of byproduct material by employees who do not meet the necessary requirements and shutting down operations, when justified, to maintain radiation safety. You are required to notify management if staff does not cooperate and does not address radiation safety issues. In addition, you are free to raise issues with the U.S. Nuclear Regulatory Commission at any time. It is estimated that you will spend 40 hours per week conducting radiation protection

activities.
