Our office has reviewed your March 29, 2022 letter requesting the removal of the authorization for the use of iodine-125 seeds (sealed sources) as permitted under Title 10 of the *Code of Federal Regulations* (10 CFR) Section 35.400, from the referenced license.

To assist our review, could you please provide a signed and dated letter indicating the following information, as available:

- The final date under which the 10 CFR 35.400 iodine-125 seeds were used for manual brachytherapy, as authorized under Subitem No. 6.D.:
- The final date on which the 10 CFR 35.400 iodine-125 seeds were stored as decay-in-storage waste, following the final medical use of the material;
- The date on which the final decay-in-storage waste containing iodine-125 waste was surveyed and disposed;
- A history of any lost or leaking iodine-125 seeds, if any, under the license; AND
- A confirmation that both the decay-in-storage waste and the areas where the iodine-125 seeds were
  used and stored have been surveyed to confirm that no residual iodine-125 activity remains, under the
  license.

If you are unable to provide all of the requested information, please provide as much as possible together with an explanation as to why additional details are unavailable. If you could provide the information within the next 7 days (on or before June 30, 2022), it is appreciated.
