Enclosed is Amendment No. 40 to SA Hospital Acquisition Group, LLC d/b/a South City Hospital's (your) U.S. Nuclear Regulatory Commission (NRC) Materials License No. 24-01381-01 in accordance with your May 24, 2022 request to replace Patrick Cabrera, D.O. with you as the Radiation Safety Officer (RSO), and to remove Matthew Pesek, D.O., as a Title 10 of the *Code of Federal Regulations* (10 CFR) Sections 35.100 and 35.200 authorized user (AU) from your license. An environmental assessment for this action is not required because this action is categorically excluded under 10 CFR 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's expectations for individuals and organizations to establish and maintain a positive safety culture.
