Dear Dr. Conn:

Based on a telephone discussion with Ms. Michelle Kritzman on August 8, 2022, it appears that the renewed license and cover letter had not been received by Beaumont Hospital - Dearborn. Therefore, enclosed is Amendment No. 133 renewing your U.S. Nuclear Regulatory Commission (NRC) Material License No. 21-04515-01 in accordance with your renewal request.

Please note that Subitems 6.D. and 6.G. on the renewed license, have not yet been removed as requested. The stated documentation regarding the disposal of licensed material was not included with the renewal application. Therefore, as discussed, please provide the documentation for the disposed license materials and the license will be amended to remove Subitems 6.D. and 6.G. from your license. Also note, as discussed, that additional letters were included in License Condition 17, regarding the HDR, Self-Shielded Irradiator and Yttrium-90 use. I am working at an alternative workstation and can be contacted via e-mail or at 815-439-8392 or 815-341-6870. Please let me know if you have any questions.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
