2 CHAIRMAN HENDRIE: The Commission now will move on
3 to a speedy affirmation session, and I hope a speedy agenda
4 planning session.

5 Mr. Chilk, are you ready to inform us?

6 MR. CHILK: I am ready to inform you.

7 CHAIRMAN HENDRIE: Good. Name the numbers; I am
8 ready to vote.

9 MR. CHILK: SECY-78-162, which is an implementation
10 of an IAEA Safeguards Requirements, and it proposes to obtain
11 Commission approval of the public comment, a proposed
12 (not understandable) regulations, a proposed rule which would
13 enable the United States to be in compliance with respect to
14 licensing activities in the IAEA Agreement enters in force.

15 The rules are being published at this time so that
16 the final regulations may be accomplished promptly once the
17 Senate gives its consent.

18 It involves a proposed rule. The appropriate com-
19 mittees are to be notified. A public notice will be issued.

20 The General Accounting Office approval of the
21 reporting requirements will be obtained before we go final
22 form.

23 All 3 of you have approved it, Mr. Gilinsky noting
24 without objection. Mr. Kennedy voted for it, although he is
25 not here. I ask you for an affirmative vote.

1 MR. BRADFORD: Aye.

2 CHAIRMAN HENDRIE: So ordered.

3 MR. CHILK: The second one, the last one, is SECY-
4 78-173. It's a request to delegate EDO additional authority
5 for dealing with petitions for rulemaking. The delegation
6 will authorize EDO to deny any petition for rulemaking which
7 doesn't substantially modify existing precedent and authorizes
8 him to propose exceptions from licensing requirements in
9 matters in which there is background and existing precedent.

10 Also, it involves the notification of Congressional
11 Committees, a public announcement.

12 All of you have voted for it, including Commissioner
13 Kennedy who is not present.

14 I ask you for an affirmative vote.

15 MR. BRADFORD: Eye.

16 CHAIRMAN HENDRIE: So ordered.

17 MR. CHILK: That is the 2 affirmations.

18 (Whereupon, at 2:43 p.m., the meeting was adjourned.)
