2 CHAIRMAN HENDRIE: Do we still have one left,
3 John?

4 MR. HOYLE: We have two.

5 CHAIRMAN HENDRIE: Please affirm us.

6 MR. HOYLE: The first one is the paper dealing
7 with medical uses of byproduct material.

8 I have each of the individual votes to publish
9 a proposed amendment to Part 34. Part 34 deals primarily
10 with procedures for safe radiographic operations.

11 I would also publish an advance Notice of Rule-
12 making identifying for public comment certain design features
13 for radiographic exposure devices and announcing a public
14 meeting to discuss those design features.

15 I have your individual approvals for publishing
16 those amendments and that announcement.

17 CHAIRMAN HENDRIE: All in favor.

18 (Chorus of ayes.)

19 So ordered. Next.

20 MR. HOYLE: The next one, we had a draft order
21 regarding Bailly on there that we have taken off. It's an
22 old one. I do hope we can get it back on as soon as we can.

23 CHAIRMAN HENDRIE: Okay, the next one.

24 MR. HOYLE: The next one is --

25 COMMISSIONER KENNEDY: When is it required? When

1 is this order required?

2 MR. HOYLE: We do not have a specific required
3 date for that order. It is an order responding to four
4 petitions for review of the denial of the Director or NRR's
5 decision.

6 The additional item is the review of ALAB-455
7 regarding Prairie Island. Each of you have agreed to an
8 extension of time within which to review. We've received
9 two petitions for review of that ALAB.

10 The staff had proposed March 31 as the date
11 to which you extend the review time. Commissioner Kennedy
12 has suggested that that date be April 7th, a week beyond
13 that, so I ask to affirm that we consider the extra week
14 to April 7th.

15 CHAIRMAN HENDRIE: Those in favor.

16 (Chorus of ayes.)

17 So ordered.

18 Those are the two that are still alive out of
19 the affirmation session.

20 COMMISSIONER KENNEDY: I thought we were going
21 to take care of that FOIA appeal concerning Gaynor. What
22 happened to that?

23 MR. HOYLE: I do not have sufficient votes to
24 bring it to affirmation.

25 (Whereupon, the meeting was adjourned at
4:45 p.m.)
