Enclosed is Amendment No. 9 to Azenta Life Sciences's (your) U.S. Nuclear Regulatory Commission (NRC) Materials License No. 13-32622-01 in accordance with your July 8, 2022 letter requesting to change the name of the licensee from Brooks Life Sciences, Inc. to Azenta Life Sciences, and to add a second building & suite number to the existing commercial storage location of use, listed on the license, and to add a new commercial storage location of use to the license. You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.
