This letter documents the Nuclear Regulatory Commission (NRC) staff's plan to perform an inspection of the Flowserve Flow Control Division - Limitorque's Appendix B, "Quality Assurance Program Criteria for NuclearPower Plants and Fuel Reprocessing Plants," to Title 10 of the *Code of Federal Regulations* (10 CFR) Part 50, "Domestic Licensing of Production and Utilization Facilities" quality assurance and 10 CFR Part 21, "Reporting of Defects and Noncompliance," programs as they pertain to activities conducted at your facility related to the design, fabrication, and testing of safety-related motor-operated valve actuators being supplied to NRC's regulated facilities. As discussed via electronic mail on August 22, 2022, the NRC inspection team plans to arrive at your facility on Monday, October 17, 2022, and will conduct an inspection through Friday, October 21, 2022. Subsequent to the inspection, a report will be issued and transmitted to you via letter.
