Dear Mr. Sarrao:

This is in reference to your letter dated July 29, 2022, requesting to terminate NRC License No. 47-17282-01. In order to continue our review, we need the following additional information:

1. Please confirm that all activities authorized by NRC License Number 47-17282-01 have ceased, and all radioactive materials procured and/or possessed by the Alecto Healthcare Services Wheeling, LLC under this license cited above have been disposed of by the waste contractor, Chase Environmental Group. Additionally, please provide the date these activities ceased.
2. In section C of the NRC Form 314, dated July 29, 2022, you indicated, by checking item 3, that a radiation survey is not required as only sealed sources were ever possessed under this license and the results of the latest leak test were attached. Contrary to the above, the license was authorized for and did possess sealed and unsealed materials. Additionally, the NRC discovered a previously unidentified sealed source that had remained onsite following the cessation of licensed activities which contained Cesium-137; this source was later determined to be leaking. Please submit radiation surveys that confirm the absence of licensed radioactive materials or that any remaining residual radioactivity is within the limits of 10 CFR 20, Subpart E, and is ALARA.

We will continue our review upon receipt of this information. Please reply to my attention at patrick-john.hann@nrc.gov.

In order to continue prompt review of your application, we request that you submit your response to this letter within 30 calendar days from the date of this letter.

While it is allowable, please refrain from submitting proprietary information in support of a license unless necessary. Keep in mind that all NRC licenses are considered to be in the public domain, and therefore may be viewed by any member of the public who requests to see them.
