SUBJECT: RESPONSE TO NRC INSPECTION REPORT 150-00042/2022-002 AND NOTICE OF VIOLATION

Dear Mr. John Hulsey:

On July 13, 2022, the U.S. Nuclear Regulatory Commission (NRC) cited Amerapex Corporation for a Severity Level IV violation of NRC requirements. The violation involved a failure to meet requirements found in Title 10 of the *Code of Federal Regulations* (10 CFR) Part 37. NRC Inspection Report 150-00042/2022-002 with enclosed Notice of Violation (Notice) required you to reply in writing in 30 days. In a letter dated August 11, 2022, you provided your reply to the Notice.

After reviewing the information provided in your reply to the Notice, we have concluded that your completed and proposed corrective actions appear to adequately address the regulatory non-compliance described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
