Enclosed is Amendment No. 79 to Zoetis LLC's (your) U.S. Nuclear Regulatory Commission (NRC) Materials License No. 21-00182-03 in accordance with your June 29, 2022 request to replace previously listed Radiation Safety Officer (RSO) John M. Stuedemann and Radiation Safety Committee (RSC) Chairperson Pamela L. Boner, R.Ph., Ph.D. on your license with, respectively, you and Raymond Zielinski. Please note that we have also updated License Condition No. 16 in accordance with NRC's standard decay-in-storage licensing condition. Finally, please note that your letter is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML22180A119. An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) Section 10 CFR 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's expectations for individuals and organizations to establish and maintain a positive safety culture.
