Question 24 (STSB) -

In attachments 2.1, 2.2, and 2.3 of the LAR¹, TVA proposed to add a RICT to Browns Ferry, Units 1, 2, and 3, TS 3.8.1 Required Action B.5 for one inoperable diesel generator. Currently, Required Action B.5 has Completion Times with nested logic related to the availability of the temporary diesel generator. The addition of the RICT to this set of Completion Times, as proposed, has the potential to be a confusing requirement. Discuss revising the nesting of the "and" logical connectors for clarity.
