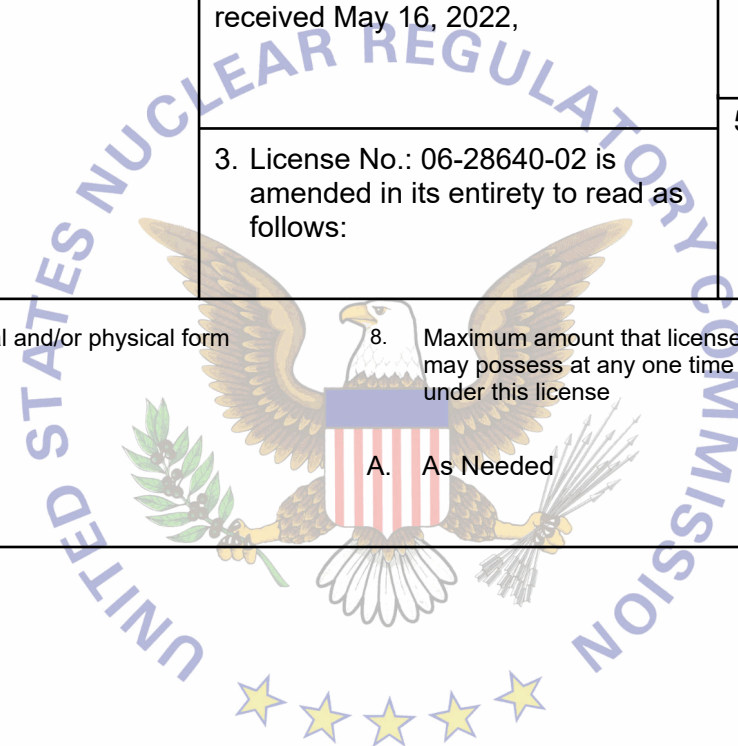


**MATERIALS LICENSE**

CONDITIONS

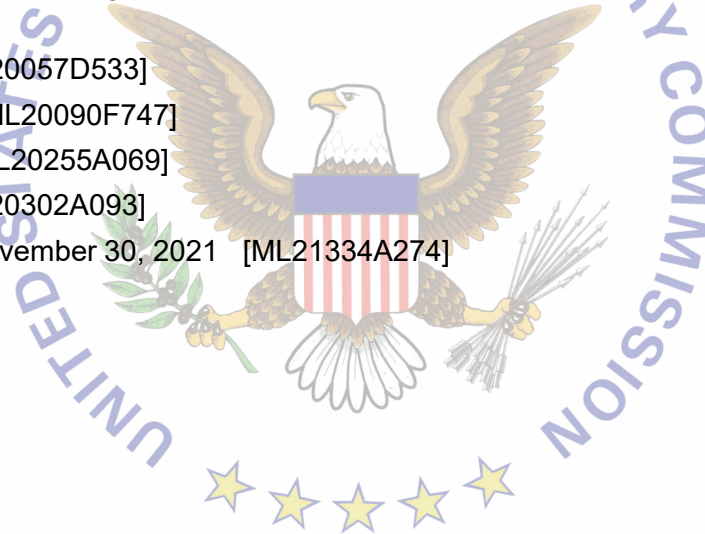
