Dear Ms. Mary Donahue:

Enclosed is Amendment No. 13 to your NRC Material License No. 24-00513-37 in accordance with your request dated June 15, 2022, regarding activities at your licensed facility. Please note that in accordance with a telephone conversation with Ms. Donahue, Radiation Safety Officer, on September 19, 2022, it was discussed to amend the license to remove the Americium-241 for research and development as requested. It was also determined that the additional requests regarding the license amendment, would be completed when the licensee provided additional information regarding the "Release Surveys" for Buildings Rooms 120, 121, 207 and 209. Based on our telephone conversation it was agreed that the rooms surveys should be modified and resubmitted for clarity and readability.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
