This refers to your license amendment request dated April 26, 2022. Please find enclosed Amendment No. 13 authorizing a new Radiation Safety Officer, a revised list of locations of use, and additional sealed sources. The facilities at the locations removed from the license may be released for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14) and (20).

You will be periodically inspected by the NRC. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
