

# Social Media Disclaimer

**A. General Policy** – The U.S. Nuclear Regulatory Commission (NRC) manages its social media platforms to provide a forum for improving communications with our stakeholders. Social media content focuses on topics that educate, inform, explain, raise awareness about the NRC and its mission, and generate dialogue. This social media policy (disclaimer) is subject to amendment or modification at any time to ensure its continued use is consistent with its intended purpose as a limited forum. By accessing NRC social media content, you understand that you download from, or otherwise obtain content or services through, the platforms at your own discretion and risk. The NRC makes no guarantee that your use of NRC social media will be error free or that access thereto will be continuous or uninterrupted.

**B. Posting Policy** – You are encouraged to share your comments, ideas, and concerns, but comments to NRC social media are reviewed for compliance to comment guidelines and may be removed. The NRC will not allow comments to remain that contain abusive, vulgar, offensive, threatening or harassing language, personal attacks of any kind, or offensive terms that target specific individuals or groups. The NRC will not allow comments to remain that are clearly off-topic, that promote services or products, or that promote or oppose any political party, person campaigning for elected office, or any ballot proposition. Comment sections are not intended to be used for contracting or commercial business with the NRC, so please do not submit as comments business proposals or other business inquiries. Gratuitous links to sites are viewed as spam and may result in a comment being removed. Communications made through social media in no way constitute a legal or official notice or comment to the NRC or any official or employee of the NRC for any purpose. In posting his or her own comments or other work to NRC social media, a commenter grants the NRC and anyone viewing them irrevocable permission to copy, distribute, make derivatives, display or perform the commenter's work publicly and free-of-charge. Moderation of comments will generally occur only during NRC regular business hours, Monday through Friday.

**C. Products References** – Any references to commercial entities, products, services or other nongovernmental organizations or individuals that are included in NRC social media are provided solely for the information of individuals using this content. These references are not intended to reflect the opinion of the NRC, the United States Government (Government), or its officers or employees concerning the significance, priority, or importance to be given to the referenced entity, product, service, or organization. Such references should not be understood to constitute official or personal endorsements of any product, person, or service. Such references may not be quoted or reproduced for the purpose of stating or implying that the NRC or the Government endorses or approves of any product, person, or service.

**D. Linking Policy** – NRC social media content may include useful hypertext links or pointers to information created and maintained by other public and private organizations and individuals. These links and pointers are solely for information and convenience of those accessing NRC social media content. When a user selects a link to an outside website, he or she is leaving NRC content and is subject to the privacy and security policies of the owner or sponsor of the outside website. **H. Reporting Emergencies and Allegations** – Do not use NRC social media platforms to report emergencies involving nuclear facilities or radioactive materials or allegations.
