SMR, LLC is submitting an update to our voluntary response to NRC Regulatory Issue Summary (RIS) 2020-02, in ML20315A139, and Revision 2 to the previously submitted SMR-160 Regulatory Engagement Plan (REP), Revision 1, in ML22210A033. The update to our voluntary RIS response is to inform the NRC process for scheduling and allocating resources for fiscal years 2023 – 2025. This RIS update and revision to the REP was discussed with the NRC staff.
