On October 5, 2022, the US Nuclear Regulatory Commission (NRC) conducted a public meeting with the Nuclear Energy Institute (NEI) and industry representatives to discuss the review of NEI’s draft guidance entitled, NEI 99-01, Revision 7 Draft G, “Development of Emergency Action Levels for Non-Passive Reactors.” The public meeting was held virtually.
