This correspondence refers to your license amendment request dated July 19, 2022. Please find enclosed Amendment No. 41 to your U.S. Nuclear Regulatory Commission (NRC) Material License No. 21-16560-01 for JAN X-Ray Services, Inc. in accordance with your request.

An environmental assessment for this action was not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (CFR) 51.22(c).

In your letter dated September 30, 2022, you provided the history of use of material at 2397 W 100 S, Rockville, Indiana 47872. Specifically, you confirmed that no licensed material had been used at this field station. Therefore, based on the information provided, no further remediation or actions with respect to NRC regulated material is required. The field station located 2397 W 100 S, Rockville, Indiana 47872, is suitable for unrestricted use.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. The NRC may issue a notice of violation, imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
