This refers to your license amendment request dated May 31, 2022. Please find enclosed Amendment No. 7 authorizing Jestin LeClair as Radiation Safety Officer. Also, License Condition No. 11 has been revised to reference the December 2, 2019 renewal application which describes John Turner Consulting's current training requirements.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
