10 CFR 50.54(q)(5) Summary of Changes for EP-MNS-EPLAN-ANNEX, Duke Energy McGuire Emergency Plan, Revision 1

In accordance with 10 CFR 50.4(b)(5)(ii), 10 CFR 50.54(q)(5), and 10 CFR 72.44(f), Duke Energy Carolinas, LLC (Duke Energy) hereby provides a brief summary of changes to EP-MNS-EPLAN-ANNEX, Duke Energy McGuire Emergency Plan Annex, Revision 1.

The changes incorporated into EP-MNS-EPLAN-ANNEX, Duke Energy McGuire Emergency Plan Annex, Revision 1, are editorial and do not change the intent of the Emergency Plan as written. This revision:

- Updates procedure format to align with the Procedure Automated System (PAS) formatting. This Duke Energy Standard formatting includes updates on the document cover page, document number, table of contents, adds a revision summary, replaces lists separated by semicolon with bulleted lists, revises section spacing and page alignment, removes the previous revisions header and footer and replaces those with a PAS standard header to each page, updates the revision number throughout the document, adds hyperlinks to procedures referenced in body of annex.
- Revises grammar mistakes found in the review of revision 0. Extra spaces, and hyphens were placed or removed between words when needed (i.e., site specific vs. site-specific, etc.).
- Updates procedure references to correct procedure numbers and titles as needed.
- Removes procedures that have been superseded by fleet procedures.
- Revises the description of the Alternate Technical Support Center from being established to being designated in the McGuire Administrative Building.
- Removes procedures that are no longer Emergency Plan Implementing Procedures.
- Adds additional procedures as Emergency Plan Implementing Procedures.

Duke Energy evaluated the above changes in accordance with 10 CFR 50.54(q)(5) and determined that they do not result in a reduction in the effectiveness of the Emergency Plan.
