## NRC Seeks Public Input on Environmental Issues for Review of Turkey Point Subsequent License Renewal Report

The Nuclear Regulatory Commission is seeking public comment on the scope of its supplemental Environmental Impact Statement concerning the subsequent renewed licenses for the two Turkey Point nuclear power reactors in Florida. The staff's additional analysis is prompted by a supplemental Environmental Report received from Florida Power & Light on June 10. The NRC is seeking comment until Nov. 7 on the appropriate scope of its supplement to the existing EIS.

[FP&L's report](#) was submitted following several related Commission decisions, one of which [concluded](#) that the generic EIS on license renewal did not analyze the environmental impacts of a subsequent license renewal term. The NRC staff's environmental review of the Turkey Point subsequent renewed license applications had relied on the generic EIS for its analysis of impacts and it was therefore deemed incomplete following the Commission's decision.

A separate Commission [decision](#) provided an option for license holders, including FP&L, to provide additional environmental information on a site-specific basis, instead of waiting for the NRC staff to revise the generic EIS and complete a related rulemaking. Turkey Point's subsequent renewed licenses [remain effective](#), with modified end dates matching those of the previous renewed licenses, until completion of the environmental analysis and a final licensing decision.

The NRC staff has [determined](#) it has sufficient information to continue the process and subject FP&L's report to a detailed technical review. It has been assigned Docket ID NRC-2022-0172. The staff intends to examine the environmental issues the Commission determined were not properly evaluated for the subsequent license renewal term, as well as any new information for Turkey Point site-specific issues. The staff is interested in public comments on the scope of the environmental review. Based on Commission direction, the NRC will issue an opportunity to request a hearing on the environmental review once the staff has produced a draft supplement to the EIS.
