Discussion: The licensee's renewal application list two locations for storage. The current license list three locations of storage. The RSO stated the facility on the license listed on condition 10.B (Amendment 17) in Ponce, PR is no longer in the possession of the licensee as this facility was sold about two years ago. The RSO stated that during his time as RSO, no gauges were stored at that facility and that leak tests for all gauges in their possession have never indicated that any gauge has leaked. The licensee stated that this location can be removed from the license.

This licensee is scheduled to be inspected in Q4 2022. Leak test records will be reviewed during the inspection to confirm the licensee's statement.
