SUBJECT: APPROVAL OF BWXT MEDICAL LTD. REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE OF CANADIAN NUCLEAR SAFETY COMMISSION (CNSC) TRANSPORT CERTIFICATE CDN/2094/B(U)-96, REVISION 4, FOR THE MODEL NO. F-522 (DOCKET NO. 71-3091)

Dear Richard Boyle:

During the review of the Canadian Nuclear Safety Commission (CNSC) Transport Certificate CDN/2094/B(U)-96, Revision 4, for the Model No. F-522 (hereafter F-522), BWXT Medical Ltd. submitted affidavit dated June 8, 2022 [Agencywide Documents Access and Management System (ADAMS) Accession No. ML22160A424], requesting that the information contained in the documents included in the table below be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Part 2, Section 2.390.

In general, the affidavit notes that the information submitted should be considered exempt from mandatory public disclosure for the following reasons:

- The information discloses descriptions of the design and analysis of the Model No. F-522 package, where prevention of its use by competitors of BWXT Medical Ltd., without license from BWXT Medical Ltd., constitutes a competitive economic advantage over other companies.
- The information, if used by a competitor, would reduce their expenditure of resources or improve their competitive position in the design, manufacturing, shipment, installation, and assurance of quality or licensing of a similar product.
- The information includes certain portions of the safety analysis report related to the design of the Model No. F-522 package, which are owned and are held in confidence by BWXT Medical Ltd.

You also should understand that the NRC may have cause to review this determination in the future, for example, if the scope of a Freedom of Information Act request includes your information. In all review situations, if the NRC makes a determination adverse to the above, you will be notified of the date of public disclosure in advance which will be a reasonable time thereafter.
