Dear Mr. Holladay:

This letter refers to your new license application dated November 10, 2022, Agencywide Documents Access and Management System (ADAMS) Accession no. ML22321A192. In reviewing your application, we have determined additional information is required to complete our review. In order to continue our review, please address the issues listed below. This information is required by Title 10 of the *Code of Federal Regulations* (10 CFR) Section 40.52, "Certain items containing source material; requirements for license to apply or initially transfer."

1. Please provide Chemical and physical form and maximum quantity of source material in each product.
2. Submit details of construction and design of each product.
3. Provide the proposed method of labeling or marking each unit, and/or its container with the identification of the manufacturer or initial transferor of the product and the source material in the product.
4. Describe the means of providing radiation safety precautions and instructions relating to handling, use, and storage of the incandescent gas mantles to be used under 10 CFR Paragraph 40.13(c)(1)(i).

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your application.

Please be aware that upon your request, proprietary information submitted to the U.S. Nuclear Regulatory Commission (NRC) may be withheld from public disclosure. To do this, you must follow the procedures in 10 CFR 2.390(b) including requesting withholding at the time the information is submitted and complying with the document marking and affidavit requirements set forth in 10 CFR 2.390(b)(1).

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public

Document Room or from the Publicly Available Records component of NRC's ADAMS. ADAMS is accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
