Please amend our accelerator production license (No. 21-35632-01) in accordance with the following specific requests:

During a review of the financial assurance letter (dated March 24, 2021) submitted with our initial application, we noted that the physical address of our facility is not specifically included and only our previous business address (400 Monroe Ave NW, Grand Rapids, MI, 49503) is listed. The intent of the letter was to cover decommissioning activities at the physical address of our facility as is implied. However, to make it clear, we have attached a new financial assurance letter from Michigan State University dated November 1, 2022, that specifies the physical address of our licensed facility at 109 Michigan St. Grand Rapids, MI, 49503.



3. The legal name of our company has changed from BAMF Health, LLC to BAMF Health, Inc. This change is only related to our name and it does not involve a change of control/ownership or a transfer of the license in any way.
