This refers to your license amendment request dated June 30, 2022. Please find enclosed Amendment No. 40 authorizing renovation of your Nuclear Medicine facility to add a new hot lab and patient injection area as part of Phase II of your renovation project.

An environmental assessment for this action was not required since this action is categorically excluded under 10 CFR 51.22(c)(14).
