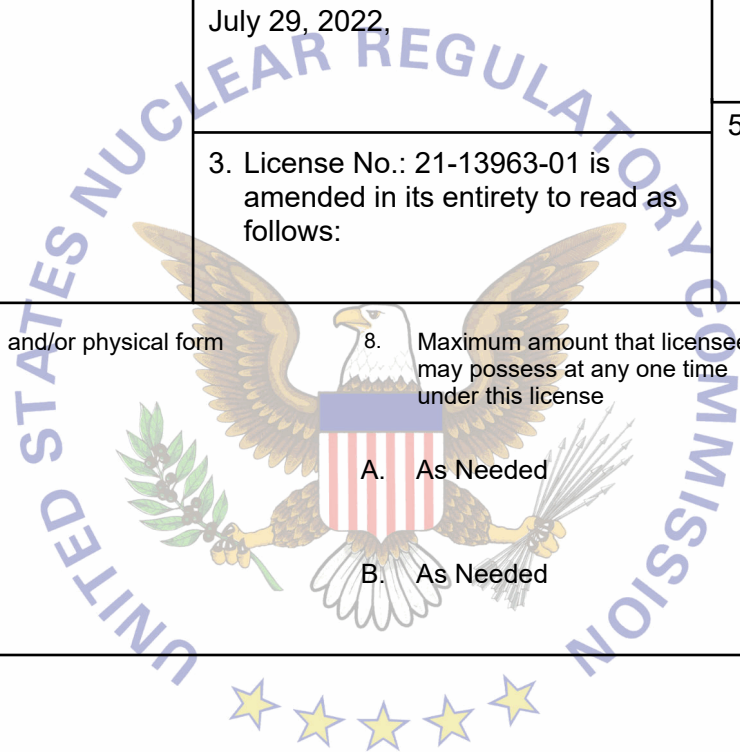


MATERIALS LICENSE

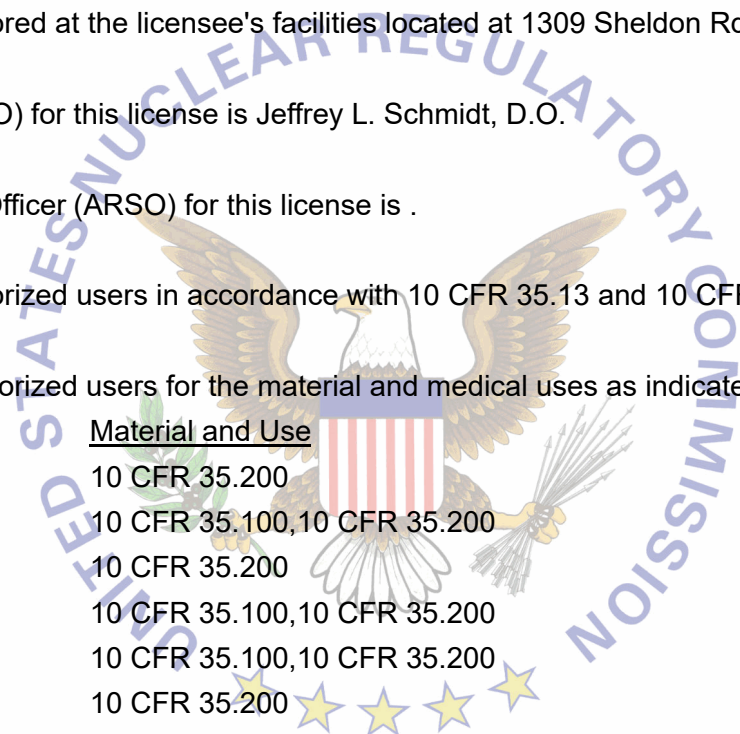

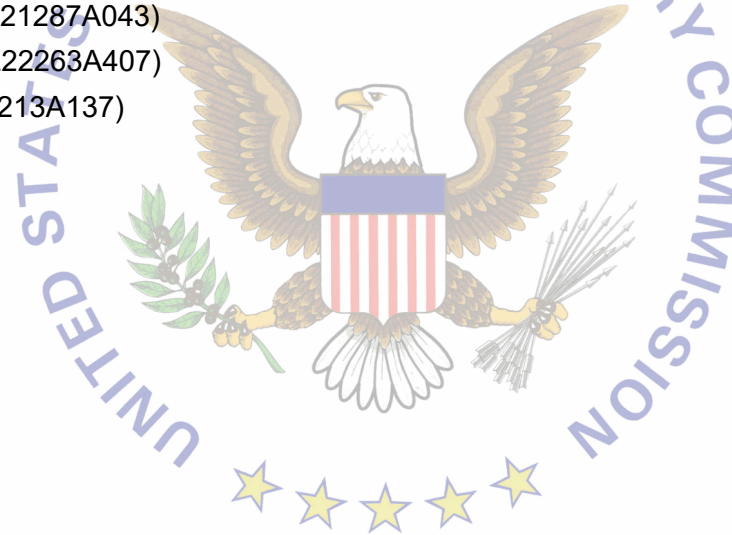
